

## UNITED SPORTS WAIVER, RELEASE, & CONSENT



- 1. I have read and understand, and freely and voluntarily enter into this Release, Waiver, Indemnification, and Consent Agreement (this "Release") with United Sports Training Center, LLC and its agents, employees, staff, volunteers, directors, and officers (collectively, "United Sports").
- 2. I acknowledge and agree that my use and/or my minor children's ("Participant's") use of any of United Sports' services, equipment, and/or premises and/or participating in any United Sports' activity, whether as a user, player, spectator, or volunteer, (collectively, the "Activities"), involves risk of injury to persons and property, including bodily injury, permanent disability, paralysis, and death (the "Risks"). I further acknowledge and agree that the Risks may arise from my own or others' supervised or unsupervised participation in the Activities and accidental injuries occurring anywhere in the United Sports facilities or premises. I further acknowledge and understand that there may be other Risks, including but not limited to, social and economic costs, damages, and/or losses which are not readily foreseeable or known to me at this time.
- 3. In consideration of Participant being permitted to enter any United Sports facility for any purpose, including, but not limited to, observation, use of facilities, services or equipment, or participation in any way, I hereby release and hold United Sports harmless from all liability, on my own behalf and on behalf of my minor children and my own and my minor children's personal representatives, assigns, heirs, and next of kin, (collectively, the "Releasees"), for any loss or damage and forever give up any claim or demand therefore, on account of any injury to Participant's person or property, including injury leading to death, whether caused by the active or passive negligence of United Sports or otherwise, to the fullest extent permitted by law, while Participants are in, upon, or about any United Sports premises and/or participating in any of the Activities.
- 4. I further authorize and agree that in the event of any emergency situation, including but not limited to any injury to Participant, I authorize United Sports to take any and all action, including medical intervention, which United Sports, in its sole discretion, deems necessary and/or appropriate and, on behalf of the Releasees, I release and hold United Sports harmless for any liability for any loss, damage, or further injuries caused thereby.
- 5. I further agree to indemnify, defend, and hold United Sports harmless for any liabilities, claims, and/or suits arising from, by, or on behalf of any of my minor children, guests, or other persons I bring, invite, or otherwise cause to be present upon the United Sports premises or facilities.
- 6. I further expressly agree that this Release is intended to be as broad and inclusive as is permitted by the law of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I affirm again that I have read this Release and agree that no oral representations, statements or inducement apart from what is stated herein have been made.
- 7. I further grant United Sports permission to use my and/or my minor children's name(s), picture(s), and/or likeness(es) in any printed, electronic, or other media for purposes of advertisement and/or promotion. Further, on behalf of the Releasees, I renounce and waive any and all claims upon United Sports for any reimbursement or compensation related to such use.
